

- 1. This Campaign is offered by Prudential BSN Takaful Berhad ("PruBSN"). By participating in this Campaign, you are bound by these terms and conditions.

- 3. The Eligible Customer must provide an accurate full name, identification number (NRIC), email, contact/mobile number and mailing/correspondence address in the proposal form or in PruBSN Touch by 1 December 2022.
